## 2024 Year in Review

### Notes from the President by Mark Spicka

The Big Spring Watershed Association kept busy in 2024 in our efforts to restore, protect, and enhance the Big Spring. We continued to conduct our biannual creek cleanups in April and October. Volunteers picked up the accumulated trash from the headwaters down through Newville. In October we were joined by State Representative Barb Gleim and members of the Newville Cub Scouts. West Pennsboro Twp. provided the truck to haul away the trash. In April, Mary Blakeslee, Laszlo Bockh, and Linda Watson took part in the Earth Day fair at the Big Spring Middle School. Through various interactive activities, they helped educate the students about the Big Spring watershed and its unique karst geology. In September, BSWA again hosted Project Healing Waters in which wounded veterans enjoyed a day of fly fishing. The Big Spring Fish and Game Association generously made available their pond for fishing and provided food for the event. Our birders continued to hold bird watching walks along the spring on the first Saturday morning of each month. Volunteers worked hard to maintain and expand the pollinator habitat at 380 Big Spring Road. After leading the planning, establishment, and maintenance of the habitat for over a decade, Mary Blakeslee is handing over leadership to Paul Christman. Don Horn and Paul Christman continued to conduct monthly monitoring of water quality, testing for pH, temperature, nitrogen, phosphates, and conductivity. (Continued on next page.)

Looking forward to 2025, we are working with the Cumberland County Conservation District and the PA Fish and Boat Commission to do in-stream habitat restoration from the “willow tree pool” parking lot downstream 1200 feet to Nealy Road. This stretch of the creek is silted in and holds little productive holding water for trout. PAFBC and the County Conservation District are applying for a County Action Plan Grant from the DEP in fall 2025 and we hope for the work to be done in summer 2026.

We continue to be highly engaged in the evaluation process of the proposed warehouses near the Big Spring headwaters. See the column to the right for details.

### Proposed Warehouse Plans Under Review by the DEP

BSWA continues to monitor and comment on the approval process of the proposed development of three warehouses on Route 11 that could negatively impact the Big Spring and surrounding residential wells. The proposed warehouses sit on about 110 acres of land at 3485 Ritner Highway. This site is within the Big Spring surface watershed. It is about 4000 feet from the headwaters of the Big Spring and less than 3400 feet from lower sections of the Big Spring. The development plans would include 1.3 million square feet of warehousing space plus impervious surfaces such as parking lots for trucks. Stormwater carrying contaminants from roofs and parking lots could drain into the Big Spring and the area's groundwater, adversely affecting water quality.

Of particular concern is the proposed construction of seven subsurface stormwater infiltration basins that would be sitting directly on porous limestone bedrock. Some of these subsurface infiltration basins would be up to 35 feet under the current surface grade, requiring blasting deep into the limestone bedrock. Current plans do not follow the DEP's best management practice of 2 feet of soil separating the subsurface infiltration basins and bedrock for filtration of stormwater. Furthermore, the plans do not follow recommend ratios of the area of impervious surfaces to infiltration basins. The concern is that such a design of the basins would encourage the creation of sinkholes on the site and that stormwater would not be adequately filtrated before entering into the ground water. With its proximity to the Big Spring, contaminated water could quickly find its way into the Big Spring, which also serves as Newville's secondary water source. Furthermore, the wells of surrounding residents could be negatively impacted by contaminated stormwater from the site getting into the aquifer.

In March 2024 the West Pennsboro Twp. Board of Supervisors approved the plans pending their approval by the DEP. The plans are currently under review by the Cumberland County Conservation District and the DEP. for the permitting of the stormwater management plans. BSWA has worked with local partners and citizens to submit comments to the DEP expressing concerns about the plans. The Borough of Newville has hired a hydrogeologist who has recommended further analysis of the site and has identified the potential danger of contamination of the ground water.
